## GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June & Shri Abang Yangfo, C/o Chandini Hotel, E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Yazali Division, Ziro II, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 25/05/2022 regarding C/o road from Tadarko to Nyorbang under upper Yachuli Rs. 50.00 lacs.

Whereas, the 1<sup>st</sup> hearing was held on 1<sup>st</sup> November' 2022 at 1030hrs as scheduled. The PIO-cum-EE(PWD), Govt. of A.P., Yazali Division, Ziro II, Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. However, Shri T.L. Teil APIO-cum-AE(PWD) represented the PIO. The Appellant Shri Abang Yangfo was present. The APIO brought information during the hearing and handed it over to the Appellant. The Appellant after receiving the information appealed the Commission to give time to go through.
