## GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June & Shri Abang Yangfo, C/o Chandini Hotel, E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Yazali Division, Ziro II, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 25/05/2022 regarding C/o Retaining wall at Govt. upper primary school at Tajgi Rs. 20.00 lacs.

Whereas, the 1<sup>st</sup> hearing was held on 1<sup>st</sup> November' 2022 at 1030hrs as scheduled. The PIO-cum-EE(PWD), Govt. of A.P., Yazali Division, Ziro II, Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. However, Shri T.L. Teil APIO-cum-AE(PWD) represented the PIO. The Appellant Shri Abang Yangfo was present. The APIO brought information during the hearing and handed it over to the Appellant.
