### GIST OF ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June & Shri Abang Yangfo, C/o Chandini Hotel, E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(WRD), Govt. of A.P., Ziro Division, Lower Subansiri District, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 17/05/2022 regarding expenditure & implementation of under SADA/SIDF/RE/RIDF/CSS/UNTIED FUND of entire Lower Subansiri District, A.P.

Whereas, the 1<sup>st</sup> hearing was held on 1<sup>st</sup> November' 2022 at 1030hrs as scheduled. The PIO-cum-EE(WRD), Govt. of A.P., Ziro Division, Lower Subansiri District, Lower Subansiri District, Arunachal Pradesh, was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed that the PIO has not furnished any information as sought in the Form-A. Since, the PIO was absent, the Commission could not hear from the PIO.

Whereas, the Commission viewed seriously the absenting of the PIO from performing the statutory duty without any prior reasonable intimation. The Commission giving reasonable opportunity directs the PIO to appear in the next date of hearing with all the information as sought by the Appellant in the Form-A Dated 17/05/2022. In case the information are not available, reasonable and satisfactory explanation has to be brought in writing. Failing which the Commission may be compelled to impose penalty on the PIO under Section 20(1) of the RTI Act 2005. The same shall be published in the wide circulating Newspapers with name and designation of the PIO.

The next date of hearing is fixed on 20th December' 2022 at 1030 hrs.

Therefore, the PIO-cum-EE(WRD), Govt. of A.P., Ziro Division, Lower Subansiri District, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
