GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Bake Kepo & Shri Taram Kenji, Chimpu near Saturday market Itanagar, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., O/o Directorate of Panchayati Raj, Itanagar, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/06/2022 regarding My Village My Development Plan under 14th Finance Commission (FFC) of entire Arunachal Pradesh.

Whereas, the 1st hearing was held on 29th November' 2022(Tuesday) at 1030hrs as scheduled. Shri Nabam Rajesh, the APIO-cum-Deputy Director (RE), Directorate of Panchayati Raj, Itanagar present in the Court. Shri Bako Kepo & Shri Taram kenji, the Appellant were present in the court stating that till date they have not received any information copy. The APIO informed that the case is under investigation of SIC and is under sub-judice in the High Court. Therefore, they cannot furnish the information sought by the Appellant till completion of inquiry and court proceeding.

Whereas, the Commission directed to the APIO to give all the details of investigation agency, case records, investigation orders, and proof of the case in the High Court as claimed by the PIO. The reply of the PIO must be with proper reasons for the satisfaction of the appellant. This process must be completed on or before the next date of hearing.

The next date of hearing is fixed on 20th December' 2022 (Tuesday) at 1030 hrs.

Therefore, the Public Information Officer, Govt. of A.P., O/o Directorate of Panchayati Raj, Itanagar, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
