ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Debia Tab, Village Tepi, PO/PS, Yazali, Lower Subansiri District, Arunachal Pradesh for non-furnishing of information by PIO-cum-EE (PWD), Govt. of A.P., Yachuli Division Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 29/09/2021 regarding C/o road from Yazali- Mengio Road to Sito Via Tepi Village under RIDF-XXII 2017-18.

Whereas, the 2nd hearing was held on 26th April'2022 at 1030hrs as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., Yachuli Division Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. However, Shri T.L. Teil, APIO-cum-AE (PWD) represented the PIO. The Appellant Shri Debia Tab was present. The information were brought during the hearing and handed over to the Appellant. The Appellant informed that the information furnished are not authenticated.

Whereas, the Commission directed the PIO to authenticate all the information and furnish the same to the Appellant. The Commission also asked the Appellant to receive the authenticated information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 3rd hearing was held on 14th June'2022 at 1030hrs as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., Yachuli Division Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. However, Shri T.L. Teil, APIO-cum-AE (PWD) represented the PIO. The Appellant Shri Debia Tab was not present in the court hearing. Shri T.L. Teil, APIO cum AE (PWD) informed the Commission that the remaining information has been sent through post office in the address of the appellant. When contacted to Appellant through mobile phone reason for not attending the today's court hearing the Appellant stated that he did not receive summon copy issued by APIC office and hence requested the commission to fix the next date of hearing.

The next date of hearing is fixed on 2nd August'2022 at 1030 hrs.

Therefore, PIO-cum-EE (PWD), Govt. of A.P., Yachuli Division Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
