ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from Shri Tania June, President (AAVS) & Shri Abang Yangfo, AGS(AAVS), C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE (RWD), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 12/11/2021 regarding implementation of schemes and Fund Sanctioned under SADA, SIDF, RE, PMGSY, (State Annual Development Agenda) 2014 to 2021.

Whereas, the 1st hearing was held on 15th March'2022 at 1030hrs as scheduled. Shri Nending Bath, the PIO-cum-EE (RWD), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission with material proof that the Appellant was intimated to deposit fee for the information but the Appellant did not respond / turn up to collect the information. The Appellant informed that he has not received any intimation from the PIO, regarding depositing of the fee for the information.

Whereas, the Commission after hearing the case thoroughly and on going through the copy of intimation letter served by the PIO, the Commission asked the Appellant to deposit fee through Treasury Challan to the PIO and collect all the information from the PIO. The Commission also asked the Appellant to go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2nd hearing was held on 10th May'2022 at 1030hrs as scheduled. The PIO-cum-EE (RWD), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh was found absent during the hearing. However, Rigi Gayi, Draftsman represented the PIO. The Appellant Shri Abang Yangfo was present. The representative informed the Commission that the Appellant did not turn up to collect the information as directed in the last hearing.

Whereas, the Commission asked the Appellant to collect the information before the next hearing. Failing which it will be presumed that the Appellant is not interested in the information and the case shall be disposed of.

The next date of hearing is fixed on 21st June'2022, 2022 at 10:30 hrs.

Therefore, **The PIO-cum-EE (RWD), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh** is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
