Whereas, an appeal under Section 19 (3) of RTI Act, 2005 has been received from **Shri Tania June, President (AAVS) & Shri Abang Yangfo, AGS (AAVS), C/o Chandini Hotel, E-Sector, Naharlagun, Distt: P/Pare, Arunachal Pradesh** for not furnishing of informations by **PIO-Cum-DHO, District Horticulture Officer, Leparada Dsitric, Basar, Arunachal Pradesh** as sought, by the Appellant under Section 6 (1) of RTI Act, 2005 on 12.11.2021 seeking information relating to:-

**(i) Fruit crops other than cost intensive crops using normal spacing without integration, cost of 1.80 lakhs. (ii) Perennial spices large cardamom, cost of 5lakhs. (iii) Water harvesting system for individuals storage of water in 20mx20mx3m ponds/tube well @Rs 100/cum, cost of 1.80lakhs. (iv) Tubular structure. Cost of 12.19lakhs. (v) Vermin compost units/Organic input production. Cost of 1lakhs. (vi) Self-propelled Horticulture Machinery. Cost of 2.50lakhs. (vii) Powered knapsack sprayer/power operated Taiwan sprayer, cost of 50Thousands. (viii) State & District Mission Offices and implementing Agencies for administrative expenses project, preparation, computerization, contingency, etc. cost of 2lakhs.**

Whereas, the Commission is satisfied that there are reasonable grounds to hear and dispose of the said appeal under the provisions of Rights to Information Act, 2005.

Now, the hearing for the said appeal is fixed on **14<sup>th</sup> March, 2022 at 1000hrs** in the Hon'ble Court of Ms. Sonam Yudron, State Information Commissioner, Arunachal Pradesh Information Commission, Itanagar.
