ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P Sangram Division, Kurung Kumey District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/11/2021 regarding Expenditure and implementation of schemes and fund sanction under SADA, SIDF, RE, Maintenance (State Annual Development Agenda) 2014-2021.

Whereas, the 1st hearing was held on 8th March'2022 at 1030hrs as scheduled. The PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that he has not received any information from the PIO.

Whereas, the Commission viewed seriously the absenting of the PIO from performing the statutory duty. The PIO / APIO were absent during the hearing, the Commission could not hear from them. So, the Commission giving a reasonable opportunity to the PIO, decided to fix next date of hearing.

Whereas, the 2nd hearing was held on 26th April '2022 at 1030hrs as scheduled. The PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh was found absent again during the hearing. The Appellant Shri Abang Yangfo was present.

Whereas, the Commission viewed very seriously the repeated absenting of the PIO from performing the statutory duty without any prior information. If the PIO is found absent in the next date of hearing, penalty U/S 20(1) of the RTI Act 2005 shall be imposed on the PIO and Arrest Warrant U/S 18 (3) (a) of the RTI Act shall be issued against the PIO. The Commission giving last and final reasonable opportunity to the PIO, decided to fix next date of hearing.

Whereas, the 3rd hearing was held on 14th June'2022 at 1030hrs as scheduled. The PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh was present during the hearing. The PIO -cum- EE(PWD) informed the Commission that he had furnish information as sought for. The Appellant Shri Abang Yangfo was not present in the court hearing. However, the Commission has given an opportunity to the Appellant to study the materials and directed to give his consent on satisfaction and dissatisfaction on next date of hearing.

The next date of hearing is fixed on 2nd August'2022 at 1030hrs.

Therefore, the PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh is hereby directed to attend in person without fail in the next date of hearing.
