**ORDER**

Whereas, the 1<sup>st</sup> hearing was held on 8<sup>th</sup> March'2022 at 1330hrs as scheduled. Engineer W. Ronrang, PIO cum EE (PWD), Khonsa, Tirap District, Arunachal Pradesh was present during the hearing and Shri Abang Yangfo, Appellant was also present in the Court. The Appellant informed the Commission that PIO did not furnish him information as sought for. The PIO informed the Commission that they received an application of the Appellant seeking information as per RTI Act 2005. On receiving the RTI application, he wrote a letter to Shri Tania June, Appellant vide No. KD/DRG/RTI/2021-22/2001 Dated Khonsa, the 6<sup>th</sup> December' 2021 that the information seeking for Period 2014 to 2021 regarding on Expenditure and Implementation of Schemes and Fund sanction under SADA, SIDF, RE, Maintenance etc are very voluminous and it will take lots of time and efforts to collect all the details of 8 years. He also stated that information seeking including that of tender details of an application fee is Rs. 500.00n (Rupees Five hundred) only. If they prepared all information data as sought by Appellant it would cost more than Rs. 200000.00 (Rupees two lakh) only. Hence, he requested the Commission to direct the appellant to file fresh application on specific point by depositing required fee amount as per RTI Rules. After that they can furnish the information without delay.

On hearing the both arguments of both the parties, the Commission ask the Appellant to file fresh RTI application to the concern deptt on specific point alongwith fresh challan.

**The next date of hearing is fixed on 10<sup>th</sup> May' 2022.**

Therefore, The PIO – cum - EE (PWD), Khonsa, Tirap District, Arunachal Pradesh, is hereby summoned to appear before this court in person on the scheduled date and time without fail.
