With reference to your letter regarding the appeal for consideration of 14th March, 2022 hearing and exemption of penalty imposed on PIO.

The Commission has gone through all available materials on record. Having done so it has been observed as follows:-

- 1) On the first hearing fixed on 6th Dec,2021. You are found absent without any intimation to the Commission.
- 2) On the 2nd hearing fixed on 7th February,2022. You are again found absent.
- 3) On the third hearing fixed on 14th March,2022. You were again found absent without any intimation to the Commission.

Having found you repeatedly remaining absent during three consecutive dates aforesaid a show cause notice dated 10th February,2022 issued against you for appearance on 14th March,2022. But neither you were present nor have you responded the Show cause notice and for which the Commission arrived at a conclusion that you have been deliberately avoiding to furnish information to the appellant and thus, you were imposed a penalty to a tune of Rs.25,000/- (twenty-five thousand rupees) only. But at this belated dated on 22/03/2022 a letter has been received from you, wherein, requested for reconsideration and for revocation of order imposing penalty upon you which cannot be considered at this stage.

In view of above facts and circumstances, I find your application for reconsideration and revocation of the Commission's order dated 22nd March, 2022 fit to be rejected.

Situated thus, your application requesting for reconsideration and revocation of the Commission's order dated 16th March imposing penalty upon you is rejected with a direction to you to comply with the said order of the Commission within a month from the date of receipt of this order and failing which an appropriate order under sub-section (2)

of Section-20 of the RTI Act, 2005 may be issued for disciplinary action against you in terms of the related service rules applicable to you.
