SHOW CAUSE NOTICE

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

To

Arunachal Pradesh,

1. **Whereas**, one Shri Kialum Lomlo Nayam filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 08.07.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-189/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 20.01.2021 relating to the matter as quoted in Form-A application.
2. **Whereas**, you, being PIO O/o the Block Development Officer, Kurung Kumey District, Damin, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.
3. **Whereas**, hearing notice of the Appeal was sent to your through registered AD vide No. EE416258062IN dated 25th November, 2021 for your appearance before the Court for hearing on 15th December, 2021 but you were found absent during the hearing without giving any intimation to this Court, thereby amounts to contempt of the Court. The Commission seriously viewed your repeated absence to be precise two (02) consecutive times and found liable for imposing reasonable penalty of your neglect in furnishing of the information's yet to the Appellant.
4. **Therefore**, you are hereby required to appear in person before the Commission (APIC) for **hearing on 19th January, 2022 at 1030 hrs** alongwith all the information's sought by the Appellant to show cause as to why you should not be imposed a reasonable penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 20 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
