SHOW CAUSE NOTICE

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

Whereas, one Shri Tagar Mibang filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 08.06.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-197/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 03.05.2021 relating the matter as quoted in Form-A application.

Whereas, you, being PIO-cum-EE (RWD), Kaying Division, District Siang, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Whereas, hearing notice of the Appeal was sent to your through registered AD vide No. EE413544262IN and again WT Message was sent to you on 26th August, 2021 through APP net for your appearance before the Court for hearing on 6th September, 2021 but you were found absent during the hearing without giving any intimation to this Court.

Therefore, you are hereby required to appear in person before the Commission (APIC) for hearing on 21st September, 2021 at 1000 hrs to show cause as to why you should not be imposed a reasonable penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 20 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
