

5. **WHEREAS**, Shri Takheng Lamnio and Shri Ram Veo jointly filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 08.01.2020 U/S 19(3) of RTI Act, 2005 vide Appeal No.APIC-07/2020, wherein, alleging against you that you have refused to furnish information sought by him under Form-A of his application dated-30.09.2019 relating the matter as quoted in Form-A application.

6. **WHEREAS**, you, being PIO-Cum-DFO, Khellong Forest Division, Bhalukpong, West Kameng, Bomdila, West Kameng District, Govt. of Arunachal Pradesh, have failed to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed of 30 days from the date of receipt of his application as provided under sub-section (1) of section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub-section (1) of section-20 of the Act.

THEREFORE, you are hereby required to appear in person before the Commission (APIC) for hearing and to furnish the replies to Show Cause Notice against you on or before 21st day of January' 2021 at 10.30 AM to show cause as to why you should not be imposed a reasonable penalty as provided in Sec-20(1) of the RTI Act for violation of sub-section (1) of section-20 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence
