- 1. Whereas,** one Shri Takam Dolu and Shri Gyamar Gunia filed a Second Appeal before the commission on 18/03/2021, Under section 19(3) OF RTI Act 2005 alleging that you have refused to furnish the information in response to his RTI application dated 19th June, 2020.
- 2. Whereas,** a complaint was also received from the Appellant on 30/08/2021. The Appellants, in its complaint, have alleged that you have furnished incomplete, incorrect and misleading information.
- 3. Whereas,** you being the PIO-EE of the RWD Division, Sagalee, Papum Pare dist. Govt. Of Arunachal Pradesh, have failed to furnish the information sought under RTI Act, 2005 to the Applicant within 30 days from the receipt of his application as provided under section 7(1) of the RTI Act without any reason

and that you have allegedly furnished incomplete, incorrect and misleading information.

4. Whereas for failure to furnish the information within prescribed period of 30 days under section 7(1) of the RTI Act and for furnishing incomplete, false and misleading information you shall liable to pay a reasonable penalty under section 20 (1) of the RTI Act 2005.

Therefore, you are hereby requested to appear in person before the commission on **22/10/2021 at 1030 hrs** to show cause as to why you should not be imposed reasonable penalty as provided in section 20 (1) of the RTI Act, 2005 and failing which matter will be heard and decided in your absence.
