**SHOW CAUSE NOTICE**

- 1. Whereas**, one Shri Nabam Tapak have filed the Second Appeal against the PIO-cum-DDSE, Deputy Director of School Education, Daporijo, Upper Subansiri District, Arunachal Pradesh, before the Arunachal Pradesh Information Commission, Itanagar on 31.03.2021 U/S 19(3) of RTI Act, 2005 vide Appeal No. APIC-100/2021, wherein, alleging against the concerned PIO that he has failed to furnish information sought by him under 'Form A' of his application dated 09.02.2021 relating to the matter as quoted in Form-A application.
- 2. Whereas**, the case is still ongoing in the Commission's Court, during the last hearing of this case held on 26<sup>th</sup> Oct, 2022 the PIO-cum-DDSE, Daporijo, Upper Subansiri District was found absent and he has not deputed any representative to represent on his behalf. The Commission seriously viewed the absent of PIO and delay in providing the information sought by the appellant and to show cause as to why you should not be imposed a reasonable penalty provided in Sub-Section (1) of the Section 20 of RTI Act, 2005 of having violated Sub-Section (1) of Section 7 of the RTI Act, 2005 failing which the matter will be heard ex-parte.
- 3. Therefore**, you are once again directed to appear in person on **16<sup>th</sup> Nov, 2022 at 1400 hrs (02.00 PM)** alongwith the replies of Shaw Cause before the Commission (APIC).
