	<p>1. The 5th hearing was held on 11th April 2022 related to the APIC No. 271, 272 & 274/2021. The Appellant Shri Tage Ruti was present. The PIO-cum-EE, RWD, Likabali was found absent. However, APIO Ms. Kirpu Nyicyor was present during the hearing but the Commission did not allowed her to represent on behalf of the PIO as she could not produced the authorization letter.</p> <p>2. The commission asked the Appellant whether he has received informations or not. On this, the Appellant informed that the PIO has not furnished complete informations as sought in Form-A. Further, the Appellant was requested to the Commission for imposition of penalty against the PIO for intentionally harassing him by not furnishing complete information till 5th hearing.</p> <p>1. The Commission viewed seriously on the absence of the PIO. Moreover, he failed to furnish complete informations to the Appellant till 5th hearing. Therefore, show-cause notice be issued against the PIO for his personal appearance before the Commission and he should furnish complete and authentic informations to the Appellant within one week as sought in Form-A. Failing, which Section 20 Sub- Section (1) of the RTI Act 2005 shall be invoked against the PIO.</p> <p>3. Due to the absence of the PIO the hearing could not be proceed on. The next date of hearing was fixed.</p> <p>4. No formal notice be issued to the Appellant as he has been already intimated during the hearing regarding the next date of hearing.</p> <p>5.
