SHOW CAUSE NOTICE

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

Whereas, one Shri Isaac Ejing filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 03.11.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-320/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 20.07.2021 relating the matter as quoted in Form-A application.

Whereas, you, being PIO-cum-BDO, Tuting, District Upper Siang, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Therefore, you are hereby required to appear in person before the Commission (APIC) for hearing on 14th March 2022 at 1000 hrs to show cause as to why you should not be imposed a reasonable penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 20 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
