

**SHOW CAUSE NOTICE**

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

To,

**Er. Minjom Padu,  
PIO-Cum-EE, PWD, Division, Basar  
District: Leparada, AP.**

**WHEREAS**, Shri Yiter Lombi & Shri Yidik Lombi filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 06.12.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-389/2021, wherein, alleging against you that you have failed to furnish information sought by the Appellant under Form-A of his application dated 18.08.2021 relating the matter as quoted in Form-A application.

**WHEREAS**, you, being PIO of the PWD, Division, Basar, District: Leparada, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

**WHEREAS**, date of hearing of the Appeals was intimated to you in advance but you were found absent consecutively during the hearings. The Commission seriously viewed the repeated absence of the PIO in person during the hearing and found liable for imposing reasonable penalty of your negligence in furnishing complete informations as sought by the Appellant.

**NOW THEREFORE**, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the replies to Show-Cause Notice against you on or before **18<sup>th</sup> April 2022 at 1000 hrs** to show cause as to why you should not be imposed a reasonable penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
