- Whereas**, one Shri Putum Kambu & Miba Romin has filed the Second Appeal against The PIO – cum- Executive Engineer, PHED, Aalo Division, PO/PS – Aalo, District – West Siang before the Arunachal Pradesh Information Commission, Itanagar, on 31.05.2022 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-406/2022, wherein, alleging against the concerned PIO that he has furnished misleading information to the appellant sought by him under 'Form-A', of his application dated 12.04.2022 relating to the matter as quoted in Form-A application.
- Whereas**, this particular case was listed for hearing on 17<sup>th</sup> August,2022 vide WT Message of 15/07/2022 **but you were found absent without any intimation during the hearing fixed on 17/08/2022, thereby amounts to Contempt of Court.** The Commission seriously viewed your absence and to show cause as to why you should not be imposed a penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1),(2) of the Section 20 of the RTI Act, 2005, since you have furnished misleading information to the appellant.
- Therefore**, you are once again directed to appear in person on **7<sup>th</sup> September,2022 at 1030 hrs** alongwith all the replies to the information sought by the appellant and also the reason of your absence on **17<sup>th</sup> August,2022 at 1030 hrs** before the Commission(APIC) and failing which, you will be issued with arrest warrant.
