JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Shri Logo Bagang against the PIO, wherein, alleging that PIO-cum-BDO, Chayangtajo (Camp Seppa) East Kameng District, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 02.08.2019; vide No.APIC-101/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 07.05.2019, whereby, seeking information as quoted: **"The Information Sought in Form-A was furnished incomplete RTI Information i.e 4(b) (i): 1 ,2, 3 (B): 2009-10, 2010-11; 3(D): 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15; 3(F): PMGAY [2014-15, 2015-16, 2017-18, 2018-19]"**.

This appeal came up for four consecutive hearings. In the fourth and final hearing today on 06.11.2019, the appellant Shri Logo Bagan is, though not present, has forwarded an application, whereby, intimating the Commission that he has duly received all informations' sought from the PIO and requested the Commission for disposal of the appeal. PIO-cum-BDO, (Camp Seppa) East Kameng District is, though not present, represented by

Gonesh Bagang, UDC, BDO's Office Chayangtajo. He also requested the Commission for disposal of the appeal.

In view of above facts and circumstances, I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed off and closed for once for all.

Judgment/Order pronounced in the open court today on this 6th day of November, 2019. Each copy of the judgment/order be furnished to the parties.


