JUDGMENT/ORDER.

This an appeal filed under sub-section (3) of Section-19 of RTI Act, 2005. Brief Fact of the case is that the appellants name above filed an RTI application on 06.02.2019 under Form-A, whereby, seeking various information's in relation, among others, the vehicular movement from Phassang Circle [Kurung Kumey] to Chayangtajo ADC Hq [East Kameng]. The appellant, having not received any response from the PIO, filed the first appeal before the same PIO-cum-ADC, Nyapin, as the First Appellate Authority on 27.04.2019 on the ground that the PIO had not furnished the information sought. Thereafter, the appellant, being felt aggrieved of having not received response from the First Appellate Authority filed this Second appeal on 23.07.2019 before the Arunachal Pradesh Information Commission (APIC), Itanagar, and the Registry, having receipt of the appeal registered as the Appeal vide No.APIC-104/2019 and issued necessary processes with fixing of hearing of the appeal on 2(two) consecutive dates on 04.09.2019 and 25.09.2019.

And, accordingly, this 25th day of September, 2019 is the last and 2nd consecutive day fixed for hearing of the appeal before the Commission. Appellant Shri Ram Veo and PIO-cum-I/c Addl. Deputy Commissioner, Nyapin, Smty Tsering Pentsom Monpa are both present. Heard both the parties and during the course of hearing the appellant expressed his satisfaction as to receipt of all information sought and requested the Commission for disposal of the appeal.

In view of above, this appeal stands disposed off and closed. Judgment/order pronounced in the open court of this Commission today on 25th of September, 2019. Each copy of Judgment/order be furnished to the parties.
