JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Shri Nitesh Kumar against the PIO, wherein, alleging that PIO, DDSE-cum-DPO, Upper Subansiri District, Daporijo, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 19.08.2019; vide No.APIC-111/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 07.08.2019, whereby, seeking information regarding "**appointment made against waiting list of PRT SSA of Upper Subansiri District**".

This matter has come up for two consecutive hearings. In the second and final hearing today on 09.10.2019 the appellant Shri Nitesh Kumar and the PIO-cum-DDSE, Tape Jeram are both presents. In terms of the direction passed by the Commission the PIO has furnished the information sought to the appellant. The appellant acknowledged the receipt of the information and expressed his satisfaction of information received from the PIO. In the result this appeal stands disposed off and closed.
