JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Shri Dolang Kor against the PIO, wherein, alleging that PIO, Executive Engineer, UD & Hosing, Palin Division, Kra-Daadi District, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 19.08.2019; vide No.APIC-119/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 19.02.2019, whereby, seeking information which are as quoted: "***In annexure- 2 & 3 as Rajiv Awas Yojana (RAY)***".

This matter has come up for two consecutive hearings. In the second hearing today on 11.10.2019 the appellant Shri Dolang Kor is represented by his lawyer Mr. Taja Garam. PIO-cum-Executive Engineer department of UD & Housing Palin Division is not present.

Heard the learned counsel for the appellant. He informed the Commission that he has been instructed by his client to intimate the Commission that the all information sought have been received from the PIO and for necessary perusal of the contain of the document received those have been found satisfactory. In the light of such submission as aforesaid learned counsel of the appellant requested the Commission for the disposal of the appeal.

In view of the facts and circumstances this appeal stands disposed off and closed.


