**JUDGMENT/ORDER**

This is a second appeal under Form-E of the RTI Act filed by Shri Tana Roma Tara against the PIO, wherein, alleging that PIO-cum-EE, PWD Sagalee Division, Papumpare District, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 03.09.2019; vide No.APIC-125/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 25.06.2019, whereby, seeking information as quoted- "**C/o Government Engineering College, Toru**".

This appeal came up for two consecutive hearings. In the second and final hearing today on 30.10.2019 the appellant Shri Tana Roma Tara and the PIO-cum-EE, PWD Sagalee Division are both not presents. However, an application has been received from the appellant that he has received the required documents sought in S/No. 9, 11, 13 and 14 from the PIO and is satisfied with all information received with a request for disposal of his appeal.

In view of above facts and circumstances, I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed off and closed for once for all.


