JUDGMENT/ORDER

This is a Second Appeal filed under sub-section (3) of Section-19 of the RTI Act and registered in the Arunachal Pradesh Information Commission, being APIC-155/2019. Brief fact of the case is that the appellant Shri Akap Bodo on 21.05.2019 filed an RTI application under Form-A of the RTI Act before the PIO-cum-Director, O/o Directorate of Geology & Mining, Govt. of Arunachal Pradesh, whereby, seeking information's regarding:-

1. *furnish the entire advertisement copy of recruitment of various post form 2004 to 2017 in respect of recruitment of AMOD'S, TECHNICAL ASSISTANT, SURVEYOR, DRAFTSMEN, UDC, LDC, DRIVER and MINING GUARDS.*
2. *Furnish the name of newspaper/newspapers and date of publication of newspaper/newspapers in which advertisement for the recruitment published.*
3. *Furnish the detailed of staff recruited on the post of AMDO'S IN 2016, 2017 & 2018 on contract/contingency basis*

This appeal has come up for five (5) consecutive hearings i.e 23.10.2019, 06.11.2019, 20.11.2019, 11.12.2019 & 08.01.2020. Today, this 8th day of January, 2020 is fixed for hearing of the appeal. Appellant Shri Akap Bodo is not present and PIO of O/o the Directorate Geology & Mining, Govt. of A.P also not present. During the last hearing of the appeal on 11.12.2019, the appellant admitted to have received all information sought but informed the Commission that some of the information received were not visible for which he lodged the complaint against the PIO. The PIO, whereupon, agreed to

furnish clear copy of information to the appellant. Now the appellant has informed the Commission by telephone that he has received clear copies of information and is satisfied with all information received.

In view of all above I find this appeal fit to be disposed off and closed for once for all. And, accordingly this appeal stands disposed off.

Judgment/order pronounced in the open Court of this Commission today on this 8th day of January, 2020. Each copy of this judgment/order be furnished to the parties.


