JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Shri Tsering Mongriju against the PIO, wherein, alleging that PIO, Executive Engineer, WRD, Bomdila Division, West Kamang District, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the commission, has been registered on 30.09.2019, vide No.APIC-135/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 04.01.2019, whereby, seeking information which are clearly mentioned in Form-A application.

This appeal has come up for hearing today on 30.10.2019. The appellant Shri Tsering Mongriju is present. PIO-cum-EE, WRD, Bomdila Division, Er. Michi Bida is, though not present, represented by Assistant Engineer (Er. Tako Kadung) of WRD Sub-Division Bomdila.

Heard both parties in person. The representative of the PIO informed the Commission that all information's sought by the appellant have already been furnished. The appellant, on his part, clearly admitted the fact that the all information sought in item No. 1 to 10 and others of his application filed under Form-A have already been received by him from the PIO. He has also admitted to have mistakenly filed an appeal before this Commission as a

complaint as to why WRD Department has released false bill to the contractor without work.

Upon hearing the appellant in person about his mistake in filing the appeal and also after having careful perusal of available materials on record, I find this appeal fit to be rejected. And, accordingly, this appeal stands rejected and in the result this case stands disposed off and closed once for all.
