JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Smti. Rani Jomoh Tawe against the PIO, wherein, alleging that PIO-cum-Director, Town Planning & Urban office, Mowb-II, Itanagar, Papumpare District, Arunachal Pradesh, has refused her to furnish the information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 18.10.2019, vide No.APIC-141/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 26.07.2019, whereby, seeking information which are as quoted: ***"Date and place of bill amendment under sections which Town Planning department empower to notify Right to Way of NH-52-A as 40 meters"***.

This appeal came up for three consecutive hearings. In the third and final hearing today on 11.12.2019 neither the appellant Smti. Rani Jomoh Tawe nor the PIO-cum-Director, Town planning and Urban, O/o Town Planning Shri Sukhvinder Singh is present. During the last hearing of the appeal on 20.11.2019 appellant expressed her dissatisfaction as to the information furnished to her and PIO on his part expressed his readiness to furnish information as sought by the appellant with a certain rectification. Accordingly, PIO was allowed to furnish the information to the appellant

with rectification of the information as required by the appellant and the appellant was, thereafter, given a time for expressing her satisfaction or dissatisfaction of the information on or before the date fixed today on 11.12.2019. But the appellant is not present today and no any information to the Commission has yet been received from the appellant.

In view of above facts and circumstances I have a reason for presuming that she is satisfied with the information received from the PIO. And, accordingly, this appeal stands disposed off and closed for once for all.
