JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section-19 of the RTI Act, 2005. Brief fact of the case is that the above named appellants jointly filed an RTI application under Form-A before the above named PIO on 02.09.2019, whereby, seeking information regarding construction of pavement road for Capital Division-B under SADA Scheme for the period from 2018 to 2019. On receipt of the application the PIO sent a letter to the appellants vide letter No. CDB/RTI/2019-20/1435-36 dated-27.09.2019, requesting him for depositing an amount of Rs.56/- (rupees fifty seven) only, being cost of the information sought. Being not satisfied with the information furnished by the PIO, the appellant filed the First Appeal before the FA-cum-SE, PWD, Capital Circle, on 09.01.2019. The First Appellate Authority, whereupon, directly forwarded the appeal to the PIO with a direction to him to directly furnish the information so sought to the appellant. Having not received the information even after such direction issued by the FA-cum-SE, PWD, Capital Circle, the appellant filed this Second Appeal before the Arunachal Pradesh Information Commission and the Registry receiving the appeal registered the same as APIC-157/2019 and processed it before the Commission for its hearing and disposal. And, hence, the present case.

Accordingly, this appeal came up for hearing before the Commission for five consecutive dates. On the last and final date of hearing fixed today on this 8th day of October, 2020 the appellants Shri Taba Gatung and Taba Begi and the representative of the PIO Er. Bhupen Tadar, Assistant Engineer, Capital Sub-Division-5/B, PWD, Itanagar, are all present through video conferencing and being heard. During the course of hearing the appellants informed the Commission that the all information so sought have been received to their satisfaction and expressed

their willingness for closure of their appeal. Accordingly, I find this appeal fit to be disposed and closed. And, hence, this appeal stands disposed off and closed.


