JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section-19 of the RTI Act, 2005. Brief fact of the case is that the above named appellants filed an RTI application under Form-A before the PIO-cum-EE, WRD, Pasighat Division, East Siang District, on 29.09.2019, whereby, seeking various information in respect of Anti-Erosion/Flood Protection Works on the Right Bank of Sisiri River for the protection of Siluk and Ngopok villages, etc. The appellants, having not received the information so sought from the PIO, filed the First Appeal before the FAA-cum-SE, WRD, Pangin Circle, on 31.10.2010. The appellant again, having not received the information so sought after such filing of the First Appeal aforesaid, filed the Second Appeal before the Arunachal Pradesh Information Commission, Itanagar, on 04.11.2019 and the Registry of the Commission, having receipt of the appeal, registered it as APIC-172/20190 and processed the same to the Commission for hearing and for disposal.

On such committal of the appeal the same has been under process of hearing before the Commission from the first date of hearing fixed on 08.01.2020 till the last date of hearing fixed today on 22.10.2020. Today both the parties, i.e, appellants and respondents (PIO) are, though not present, a written application has been received from the appellant Shri Arsang Pertin, wherein, informing the Commission that he is satisfied with the information received from the PIO Er. Tamoh Jamoh. Having receipt of this written application of the appellant regarding his satisfactory receipt of the information so sought I do not find any reason for proceeding any further of this appeal, in as much as, the same automatically becomes infructuous.

In view of above this appeal stands disposed off as infructuous. Judgment/ order pronounced in the open Court of this Commission today on this 22nd day of October, 2020. Each copy of this judgment/order be furnished to the parties.


