**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from **Shri Lido Ete, Village Bene, PO/PS Aalo, West Siang District, Arunachal Pradesh**, for non-furnishing of information, by **Shri Michi Nibo, PIO-cum-EE(RWD), Aalo, West Siang District, Arunachal Pradesh**, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 30/07/2019.

Whereas, 1<sup>st</sup> hearing was held before the Hon'ble Court of Shri Leki Phuntso, then State Information Commissioner, APIC, Itanagar on 10<sup>th</sup> February'2020. The PIO was directed to furnish the information to the Appellant but the Appellant vide letter No. NIL Dated 14/05/2020 informed that the PIO has not furnished the information even after the expiry of 40 days. However, due to lock down imposed by MHA & State Govt. for COVID-19 pandemic from 25<sup>th</sup> March'2020 and retirement of Shri Leki Phuntso, State Information Commissioner on 7<sup>th</sup> April'2020 from APIC and hearing could not be completed by Shri leki Phuntso, SIC before his retirement. Therefore, the hearing is being continued before the Hon'ble Court of Dr. Joram Begi, SIC, Itanagar.

Whereas, the 2<sup>nd</sup> hearing was held before the Hon'ble Court of Dr. Joram Begi, SCIC, on 30<sup>th</sup> June'2020 through online Video / Audio conferencing. Shri Michi Nibo, PIO-cum-EE(RWD), Aalo, West Siang District, Arunachal Pradesh, and the Appellant Shri Lido Ete attended the hearing through online audio conferencing. The PIO vide letter NO. EEA/RWD/RTI-01/2019-20/37-42 Dated Aalo, the 29<sup>th</sup> August'2019 informed the Commission that the available information has been furnished to the Appellant. The PIO also has submitted a copy of Memo No. LM/WS-03/242 Dated Aalo, 03/02/2030 forwarded by the DC, Aalo, West Kameng, informing the availability of the Land for the Construction of Double court indoor badminton stadium at Aalo. The Appellant informed the Commission that the PIO had informed that the information will be furnished but till date information has not been furnished.

Whereas, the Commission on examination found that there is a technical defect in seeking the information by the Appellant. As, the Appellant applied Form-A, on 30<sup>th</sup> July'2019 and the work has been started only after land made available i.e. after 3<sup>rd</sup> February'2020. Therefore, the available information furnished by the PIO to the Appellant, is found to be sufficient at the time of application made by the Appellant.

Therefore, the case is hereby disposed of.
