ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tsering Mongriju, District President ACCCCAP, Bomdila-Unit/ Police Colony ,Near Durga Mandir, West Kameng District, Arunachal Pradesh, for non-furnishing of information by Shri Dakken Riba, PIO-cum- Dy. Director of School Education, Bomdila West Kameng District, Arunachal Pradesh as sought by the appellant under section 6(1) of RTI Act, 2005 on 20.11.2018.

Whereas, the 1st hearing was held on 23.03.2019. Shri Dakken Riba, PIO-cum- Dy. Director of School Education, Bomdila, West Kameng District, Arunachal Pradesh and the appellant Shri Tsering Mongriju were present during the hearing.

Whereas, the PIO informed the Commission that all the informations have been furnished to the appellant but appellant informed that he has received only the partial informations.

Therefore, the Commission directed the PIO to furnish all the remaining informations sought by the appellant before 7th May'2019 and asked the appellant to convey his satisfaction or dissatisfaction in the next hearing.

Whereas, the 2nd hearing was held on 14.05.2019. Shri Dakken Riba, PIO-cum-Dy. Director of School Education, Bomdila, West Kameng District, Arunachal Pradesh and the appellant Shri Tsering Mongriju were present during the hearing.

Whereas, the appellant informed the Commission that he has received the informations on 9th May, 2019 and did not have enough time to go through. So, the appellant appealed the Commission to give sufficient time to verify and cross check the informations along with the personal inspection of the schools located at five different places.

Whereas, the Commission, considering the appeal of the appellant, the next date of hearing is fixed.

Whereas, the 3rd hearing was held on 18th June, 2019. Shri Dakken Riba, PIO-cum- Dy. Director of School Education, Bomdila, West Kameng District, Arunachal Pradesh and Shri Tsering Mongriju, Appellant were present in the hearing. The appellant informed the Commission that he has received all the informations as sought for and he is fully satisfied with the informations provided by the PIO.

Therefore, the case is hereby disposed of.
