JUDGMENT/ORDER

This is a second appeal registered in the APIC, being APIC-No. 41/2019. Brief fact of the case is that Kocho Nampe & Kumar Tayem on 31.10.2018 filed an RTI application under, Form-A of RTI, Act, before the PIO-cum-EE, RWD Seppa Division, East Kameng District Arunachal Pradesh, whereby seeking various information's against the work called as – **"C/o CC steps with Iron Hand ralling from Ato Polo Colony to Buddhist Gumpa Seppa."**

This appeal came up for three hearings on 13.03.2019, 08.05.2019 & 29.05.2019. During the course of 2nd hearing on 08.05.2019 the appellant admitted to have received the information sought from the PIO and sought for a reasonable time for verification of documents received from the PIO. Accordingly, Commission gave him a week time for the verification of documents, with a direction to him (Appellant) to report to the Commission about his satisfaction or dissatisfaction of information received from the PIO on or before next date fixed on 29th of May, 2019 for further order.

Today is the date fixed for disposal of this appeal on this 29th day of May, 2019. The PIO is present but the appellant Shri Kocho Nampe is neither present nor has he reported to the Commission through any means about his satisfaction or dissatisfaction of the information received.

In the view of above the Commission has presumed under the law that the appellant is satisfied with the information received and, accordingly, this appeal stands disposed off and closed.
