**JUDGMENT/ORDER**

This is an appeal received from Shri Shoney Pertin and registered in this Commission vide No. APIC-47/2019. Brief fact of the case is that the appellant on 28.11.2018 filed an RTI application under Form-A before one Shri Tamoh Jamoh, PIO-cum-Executive Engineer, WRD, Pasighat Division, East Siang District Arunachal Pradesh, wherein, seeking various information's the name of work as "**C/o Embankment for flood protection from RWD Bridge point at Rosam Korong to Kaki Boggo at Kiyit Village under Mebo (under untied fund 2017-18).**"

The Registry after registration of appeal as aforesaid issued processes for hearing of the appeal. And, accordingly, the appeal came for hearing before the Commission for as many as 2 (two) consecutive times, i.e, on 31.07.2019 & 28.08.2019.

The matter has come up today on this 28<sup>th</sup> day of August, 2019 before the Commission for second consecutive hearing of the appeal. Appellant Shri Shoney Pertin and the PIO, Er. Tamoh Jamoh are both present and being heard.

In the course of hearing the PIO informed the Commission that the all information sought have already been furnished and appellant, whereupon, admitted to have received all information sought well within prescribed period of 30 days. Upon hearing the both parties and also after having careful consideration of available material on records I am well convinced of the fact that the appellant had received all information's which he had sought in Form-A of his application from the PIO within prescribed of 30 days as provided in sub-section (1) of Section-7 of the RTI Act.

Considering the facts and circumstances aforesaid I find this appeal fit to be dismissed. And, accordingly, this appeal is dismissed and closed once for all.


