**JUDGMENT/ORDER**

This is an appeal under Form-E of the RTI Act filed by Shri Shoney Pertin against the PIO, wherein, alleging, among others, against Shri/Er. G. Lpir, PIO-cum-Executive Engineer RWD, Yinkiong Division, Upper Siang District, Government of Arunachal Pradesh, to the effect that the said PIO has refused him to furnish information sought by him under RTI Act. The appeal, having been received, has been registered on 01.05.2019, vide No.APIC-51/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 23.01.2019, whereby, seeking various information's regarding the "**PMGSY Roads executed and under execution in Upper Siang District of Arunachal Pradesh from 2013-18**". Having receipt of the same registry of the Commission registered it and name as aforesaid and issued necessary processes for hearing of the appeal. Accordingly, the appeal came for hearing before the Commission for 2 (two) consecutive times, i.e, on 31.07.2019 & 28.08.2019.

Today, i.e, this 28<sup>th</sup> day of August, 2019 is the last or second consecutive date fixed for hearing of the appeal. Appellant Shri Shoney Pertin and the PIO Er. G. Lpir are both present and being heard. In the course of hearing

the appellant admitted to have the information's so sought from the PIO and further expressed his satisfaction as to receipt of all information sought from the PIO. And, accordingly, this appeal stands disposed off and closed for once for all.


