ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Kirgo Sora, D-Sector, Naharlagun, C/o K.G Nivas-Room no.5, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by Shri Rigio Tabam, DTO-cum-PIO, Department of Tourism, Govt. of Arunachal Pradesh, Itanagar as sought by him under section 6(1) of RTI Act, 2005 on 10.12.2018.

Whereas, the 1st hearing was held on 21st May, 2019. Shri Rigio Tabam, DTO-cum-PIO was absent during the hearing. However, he submitted a letter NO. NIL Dated 20/05/2019 informing the Commission that he is on paternity leave and his inability to attend the court. The appellant Shri Kirgo Sora was present in the hearing.

Whereas, the appellant inform the Commission that the PIO has furnished him with only three informations and he is not satisfied with the informations furnished by the PIO.

Whereas, the Commission could not proceed with the hearing in the absence of the PIO. Hence, the Commission decided to fix next date of hearing.

Whereas, the 2nd hearing was held on 18th June,2019. Shri Kirgo Sora, Appellant was present in the hearing but Shri Rigio Taba, DTO-cum-PIO was absent. The Appellant informed the Commission that the PIO furnished all the informations on 17th June,2019 and he is satisfied with the informations provided by the PIO.

Therefore, the case is hereby disposed of.


