JUDGMENT/ORDER

This is the second appeal under Form-E of the RTI Act filed by Shri Tako Tagum against the PIO, wherein, alleging that PIO-cum-PD, Lower Subansiri District, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 08.05.2019; vide No. APIC-67/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 19.01.2019, whereby, seeking information as quoted in the Annexure-I of Form-A.

This appeal came up for nine consecutive hearings. In the ninth and final hearing today on 04.03.2020, the appellant Shri Tako Tagum is, though not present, submitted a written application addressed to the Commission that he has received all the information furnished to him by the PIO and expressed his satisfaction about the information received and further requested for disposal of the appeal.

In view of all above I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed for once for all.


