ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Ms Toter Ete, Ziro Point, Near SE PWD office, Itanagar, for non-furnishing of information by Shri H. Robin, Dy. Director-cum-PIO, Directorate of Sports, Govt. of Arunachal Pradesh, Itanagar, as sought, by her under section 6(1) of RTI Act, 2005 on 05.03.2019.

Whereas, the 1st hearing was held on 4th June, 2019. Shri H. Robin, Dy. Director-cum-PIO and the authorized representative of Ms Toter Ete, Shri Kartum Ete were present during the hearing. The representative of the appellant informed the Commission that no information has been furnished to them by the PIO. The PIO informed the Commission that the information sought by the appellant are for the years 2002 to 2004 and the file containing the information is found missing. So information could not be furnished to the appellant. The PIO sought for a reasonable time to trace out the file and furnish the information..

Whereas, the Commission while according reasonable time, directed the PIO to trace out the missing file and furnish the information to the appellant before the next date of hearing failing which the PIO was to be imposed penalty under Section, 20(1) of the RTI Act in the next hearing.

Whereas, the 2nd hearing was held on 30th July, 2019. Shri H. Robin, Dy. Director-cum-PIO was present during the hearing. But Ms Toter Ete, Appellant was absent. However, the appellant informed the Commission vide her letter No. nil dated 30th July, 2019 that she has received all the informations as sought by her and is satisfied with the informations furnished by the PIO.

Hence, the case is hereby disposed of.
