JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Shri Tajum Dadi against the PIO, wherein, alleging that PIO-cum-EE, PWD Daporijo Division, Upper Subansiri District, Arunachal Pradesh, has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 19.06.2019; vide No.APIC-90/2019.

Brief fact of the case is that the appellant filed an application to the PIO under Form-A of the RTI Act on 29.01.2019, whereby, seeking information as quoted- ***“Central sponsored scheme-NLCLPR/CRL/NEC/CSS/RDFS/PMGSY at PWD Division Daporijo”***.

This appeal came up for six consecutive hearings. In the sixth and final hearing today on 18.12.2019 the appellant Shri Tajum Dadi and the PIO-cum-EE, PWD Daporijo Division, Er. Gem Dopum are both presents. After hearing both parties and also after having careful perusal of the available materials on record I find that the appellant has sought such information which are large in numbers and of a total period of five years and the same, as such, could not have been possible for the PIO to furnish to him within a month in one go. And those all information sought, if being

asked to be furnish, would take long period of time and may also divert disproportionate resources of the public authority concern, and as such, this application cannot be allowed in terms of sub-section-(9) of Section- 7 of the RTI Act.

In view of above the appellant being asked to file fresh application for seeking the information sought in this application in specific and clear manner which can be furnished by the PIO to him within a prescribed period of time under the RTI Act. And, accordingly, this appeal stands disposed off with a liberty to the appellant for filing fresh application/applications for the same information in a clear, specific and in such manner that the PIO can furnish the information within prescribed period of time under the Act.
