JUDGMENT/ORDER

This is a Second Appeal filed by the appellant Shri Chera Tatung under sub-section (3) of Section-19 of the RTI Act, 2005. Brief fact of the case is that the appellant filed an RTI application under Form-A before the PIO on 04.03.2019, whereby, seeking various information regarding VFR Scheme at Langruk village under Leporiang Forest Range. The appellant, having not received the information sought from the PIO, filed the First Appeal under sub-section (1) of Section-19 of the Act before the First Appellate Authority-cum-Principal Chief Conservator of Forest, Department of Environment & Forest, Govt. of Arunachal Pradesh, Itanagar, on the plea of non-furnishing of information by the PIO. The appellant, being aggrieved of having not received the information from the FAA, filed this Second Appeal before the Arunachal Pradesh Information Commission on 21.06.2019 under sub-section (3) of Section-19 of the RTI Act, and the same, after having receipt by the Registry, was registered vide APIC-95/2019 and issued processes with fixing of hearing of the appeal on 14.08.2019

According, the appeal has come up today for the first time before the Commission for hearing on this 14th day August, 2019. But neither the appellant nor the PIO is present for hearing of the appeal. However, a letter written on 08.08.2019 has been received from the appellant, wherein, the appellant has requested the Commission for disposing off of his appeal with an intimation that he has received all information sought under RTI Act from the

PIO to his satisfaction of the information received and the letter received from the appellant has been taken on record for consideration.

Upon considering the contents of the letter received from the appellant as aforesaid I am well convinced that the appellant is satisfied with the information received and is willing to get his appeal disposed off. And, accordingly, this appeal is disposed off and closed for once for all.
