JUDGMENT/ORDER

This is a second appeal registered in the APIC, being APIC-No. 147/2019. Brief fact of the case is that one Shri Tame Tattep on 17.07.2019 filed an RTI application under, Form-A of RTI Act, before the PIO-cum-EE, O/o the Superintendent Engineer, Yachuli Civil Circle PWD, District Lower Subansiri, Arunachal Pradesh, whereby seeking various information against the appointment of Yachuli Civil Circle- Contract/WC/Adhok Surveyor, UDC and LDC from January 2015 to till date.

This appeal came up for five consecutive hearings i.e. on 06.11.2019, 20.11.2019, 11.12.2019, 08.01.2020 and 12.02.2020. In the last and final hearing today on 12.02.2020 the appellant Shri Tame Tattep is, though not present submitted a written application to the Commission informing that all information sought have been furnished by the PIO and requested the Commission for the closure of his appeal filed by him.
