ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Nong Perme, Pasighat Ward No.-6, Po/Ps-Pasighat, East Siang District, Arunachal Pradesh, for non-furnishing of information, by Shri Hage Lailang, PIO-cum-ADC Mebo, East Siang District, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 14/10/2019.

Whereas, 1st hearing was held before the Hon'ble Court of Shri Leki Phuntso, then State Information Commissioner, APIC, Itanagar on 10th February'2020 and the PIO was directed to furnish information to the Appellant on or before 24th February'2020. However, due to lock down imposed by MHA & State Govt. for COVID-19 pandemic from 25th March'2020 and retirement of Shri Leki Phuntso, State Information Commissioner on 7th April'2020 from APIC and hearing could not be completed by Shri leki Phuntso, SCIC before his retirement. Therefore, the hearing is continued before the Hon'ble Court of Dr. Joram Begi, SIC, Itanagar.

Whereas, the 2nd hearing was held before the Hon'ble Court of Dr. Joram Begi, SCIC, on 23rd June'2020 through online Video / Audio conferencing. Shri Hage Lailang, PIO-cum-ADC Mebo, East Siang District, Arunachal Pradesh, and the Appellant, Shri Nong Perme attended the hearing through audio conferencing. The PIO informed the Commission that all the information has been furnished to the Appellant as directed by the Commission. The Appellant also informed the Commission that the PIO has furnished all the information as sought by him and the Appellant is satisfied with the information furnished by the PIO.

Therefore, the case is hereby disposed of.
