JUDGMENT/ORDER

This is a second appeal under Form-E of the RTI Act filed by Shri Ram Veo and Thaken Lamnio against the PIO, wherein, alleging that PIO-cum-DFO, Khellong Forest Division, Bhalukpong, West Kameng District, Arunachal Pradesh has refused him to furnish information sought by him under RTI Act. The appeal, having been received in the Commission, has been registered on 08.01.2020, vide No.APIC-07/2020.

Brief fact of the case is that the appellants filed an application to the PIO under Form-A of the RTI Act on 08.01.2020, whereby, seeking information which are as follows:-

1. Furnish the issue of LOC for the months of February and March 2017 under Non-plan head for the financial year 2016-2017.
2. Payment details made to the Firm of the same, along with cheque counter file/demand draft with date of issuing of Cheque/Draft No.
3. Total amount sanction order against Khellong Forest Division for non-plan head, for the years 2014-2017.
4. Detail advertisement of Local or National newspapers of the said work.
5. Detail photographs of work location along with completion certificate.
6. Total sanction amount under CAMPA against Khellong Forest Division, Bhalukphong, from 2014-2019.
7. Detail work award lists along with the merit or evaluation work offers for CAMPA for the financial year 2014-2019.
8. Detail of payment made to the Firm for, CAMPA with Cheque/Draft No. along with date of issuing of Cheque/Draft of 2014-2019 financial year.
9. Any discrepancy found on the part of executants during the Firm evaluation and recommendation report on the above mentioned.

This appeal came up for hearing before the Commission for eight consecutive hearings. In the eighth and final hearing today on 05.08.2021 the appellant and the PIO are both present before the Commission through video conferencing due to second wave of Covid-19 pandemic. PIO informed the Commission that he has furnished all information so sought by the appellants on 15th July' 2021. Shri Takheng Lamnio appearing for himself and another appellant Shri Ram Veo expressed his satisfaction of receipt of all information sought from the PIO.

In view of above facts and circumstances, I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed off and closed for once for all.

Judgment/Order pronounced in the open Court of this Commission today on this 5th day of August' 2021. Each copy of Judgment/Order be furnished to the parties.


