ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Mani Pabin, Village Lissing, PO/PS Boleng, Siang District, Arunachal Pradesh, for non-furnishing of information, by Shri Tanyang Tatak, PIO-cum-DDSE, Boleng, Govt. of A. P., Siang District, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 21/10/2019.

Whereas, the 1st hearing was held on 18th February, 2020. Shri Tanyang Tatak, PIO-cum-DDSE Boleng and the Appellant Shri Mani Pabin were present during the hearing. Shri Tanyang Tatak, informed the Commission that he has been transferred to Mechuka and now he is not the PIO-cum-DDSE Boleng and also informed that the present PIO is Shri Mutsen Perme, DDSE Boleng. The Appellant informed that he has not received any information.

Whereas, the Commission asked the Appellant not to insist for the information for MDM as the information for the same was sought by Shri Tagar Mibang, vide APIC No.195/2018 Dated 19th March'2019 and penalty was imposed on the PIO for not maintaining the proper records of the MDM scheme. However, some information were furnished to Shri Tagar Mibang. The Appellant may seek those information from the PIO. The Appellant may insist for the Sanitary Napkin and Chief Minister's Aadhunik Shiksha Yojana (Smart Class Room). The new incumbent Shri Mutsen Perme, PIO-cum-DDSE is directed to furnish the information within the 5th March, 2020 to the Appellant.

Whereas, the 2nd hearing was held on 17th March, 2020. Shri Mutsen Perme, PIO-cum-DDSE Boleng and the Appellant Shri Mani Pabin were present during the hearing. The PIO informed the Commission that all the information sought has been furnished to the Appellant on 4th March'2020. The Appellant requested the Commission to give some more time to go through the information as the information furnished is voluminous. Whereas, the Commission giving reasonable opportunity to go through the information fix the next date of hearing.
