ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Hage Tachang, Popu Hill Colony, Oppt. S.E. PWD, Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information, by Shri Nixon Lego, PIO-cum-Jt. Director, Govt. of A.P. O/o The Chief Engineer, UD & Housing, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 17/01/2020.

Whereas, the 1st hearing was held through online Video / Audio conferencing on 4th August' 2020. Shri Nixon Lego, PIO-cum-Jt. Director, Govt. of A.P. O/o The Chief Engineer, UD & Housing, Arunachal Pradesh appeared in the hearing through online video conference. The Appellant Shri Hage Tachang was present during the hearing. The PIO informed the Commission that the information sought by the Appellant is not clear what he is seeking for. However, it was assumed that he was asking for the rules for the appointment of Contingency post and seeking for appointment to the Contingency post. The Rules for the appointment of the Contingency post has been furnished to him and appointment to post of Contingency is not possible.

Whereas, the Commission on scrutinizing the Application of the Appellant seeking information under RTI Act 2005, It has been found that the Appellant has made request to the PIO on following matters.

- (1). Seeking Appointment as contingency sweeper, chowkidar etc.
- (2). Appointment letters of all contingency peon, sweeper etc.
- (3). Government of Arunachal Pradesh rules for appointment of contingency peon, sweeper, chowkidhar.

Therefore, the Commission made it clear that his request on Sl.no. 1 above does not fall within purview of the RTI Act. However, the PIO is to furnish the information as requested under Sl.no. 2 & 3.

The PIO inform the Commission that he has already furnish the Govt. of Arunachal Pradesh Rules for appointment of contingency personnel and he would be furnishing the list of contingency persons along with the appointment / engagement orders of all contingency persons of Office of the Chief Engineer, UD & Housing, Govt. of Arunachal Pradesh, Itanagar within ten days.

Whereas, the 2nd hearing was held through online Video / Audio conferencing on 15th September' 2020. Shri Nixon Lego, PIO-cum-Jt. Director (UD), O/o The Chief Engineer, UD & Housing, Govt. of Arunachal Pradesh appeared in the hearing through online audio conference. The Appellant Shri Hage Tachang was physically present during the hearing. The PIO informed the Commission that the information has been furnished to the Appellant as directed by the Commission in the previous hearing. The Appellant also informed the Commission that he has got all the information as sought by him in the Forma-A and agreed to dispose of the case.

Therefore, the case is hereby disposed of.
