**ORDER.**

Appellant Shri Rosman Tawsik and PIO-cum-PD, DRDA, Anjaw District Shri Pama Bagang are both not present. However, the appellant name above has submitted an application to the Commission, wherein, Informing the Commission that the information sought have already been received by him from the PIO and thus requested for disposing of this appeal filed by him against the PIO.

Brief fact of the case is that the appellant on 19.03.2020 filed an RTI application under Form-A before the PIO, wherein, seeking various information's regarding maintenance of FSB over Lohit River to connect Nukung Village ,under MLA LADS, 2019-20. Being aggrieved of having not received the information sought from the PIO within prescribed period of time, he filed a First Appeal date nil before the first Appellate Authority-cum-Deputy Commissioner, Anjaw District.

Having not received the information so sought either from the First Appellate Authority, he fled the Second Appeal before This Commission on 05.07.2020. The registry of the Commission (APIC), having receipt of same, registered it being APIC No/110/2020, processed for its further hearing and disposal. Accordingly, the Commission heard the appeal on 3 (three) consecutive dates on 22.10.202, 19.11.2020 & 18.02.2021. And in the process today is the 4<sup>th</sup> hearing fixed for disposal of the appeal.

Now, having receipt of the written request of the appellant for dispose of the appeal filed by him as aforesaid, I find this appeal fit to be disposed of and close as in fructuous, in as much as, the appellant is found satisfied with the information he has already received from the PIO. And, accordingly, the appeal is disposed of and closed. Each copy of this order be furnished to the either party.


