**JUDGMENT/ORDER**

This is a second appeal under Form-E of the RTI Act filed by Shri Mamu Sono against the PIO, wherein, alleging that PIO, Elementary Education Department, Govt. of Arunachal Pradesh, Itanagar, has refused to furnish him information sought in Form-A under RTI Act. The appeal, having been received in the Commission, has been registered on 16.01.2020, vide No.APIC-12/2020.

Brief fact of the case that the appellant filed an application to the PIO under Form-A of the RTI Act on 01.11.2019, whereby seeking various information's information which are as follows:-

- a) Furnish the total sanctioned amount for Mid-Day- Meal and students school uniform for East Kameng District Seppa.
- b) Furnished the copy of order sanctioned by the central and state government Mid-Day Meal and students School Uniforms for East Kameng District Seppa.
- c) Furnish the copy of completion report form the Department of DDSE East KameNG District Seppa.
- d) Furnish copy of compliant report by any union/Org/Association and any individual against the said above scheme.
- e) Furnish the copies amount sanctioned by the state and central Government.
- f) So far how many Mead-Day-Meal and students Uniformas Scheme were supplied for East Kameng District Seppa.
- g) Furnish the copy of utilisation certificate, monitoring report and name the exact location/place of implementing along video/photo clipsof said Scheme submitted by DDSE East Kameng District Seppa.
- h) Furnish the guideline copies of said above Schemes.

Today, i.e, this 18<sup>th</sup> day of March, 2020 is the last or second consecutive date fixed for hearing of the appeal. Appellant Shri Mamu Sono is present. PIO-cum-JD Elementary Education Mr. Otem Tayeng and Branch Officer Establishment Elementary Education Department Mr. Duken Kato are also present. All parties being heard. In the course of hearing the appellant admitted to have received the information's so sought from the PIO and further expressed his satisfaction as to receipt of all information sought from the PIO. And, accordingly, this appeal stands disposed off and closed for once for all.


