ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Shoney Pertin, President Siang Rights Forum(SRF), Airfield Pasighat, Ward No-4, Po/Ps-Pasighat, East Siang District, for non-furnishing of information, by Shri R.N. Singh, PIO-cum-EE(PWD), Yingkiong Division, Upper Siang District , Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 14/01/2020.

Whereas, the 1st hearing was held through online video / audio conference on 10th November'2020. Shri R.N. Singh, PIO-cum-EE(PWD), Yingkiong Division, Upper Siang District , Arunachal Pradesh, attended the hearing through online audio conferencing and the Appellant Shri Shoney Pertin appeared in the hearing through online video conferencing. The Appellant informed the Commission that the PIO has not furnished information for the Sl.no. 14, i.e. *Copy of progress work details along with colouring photograph before and after execution of the work site*. The other information furnished by the PIO are not legible. The PIO informed the Commission that the information are voluminous therefore, the PIO will be meeting the Appellant at his camp office Pasighat on 16th November'2020, (Monday) and furnish all the legible information with authentication to the Appellant.

Whereas, the Commission directed the PIO to furnish all the authenticated legible information to the Appellant as sought by him in the Form-A on or before 17th November'2020. The Commission asked the Appellant to receive the information go through and convey his satisfaction or dissatisfaction before the next date of hearing.

Whereas, the 2nd hearing was held through online video / audio conference on 24th November'2020. Shri R.N. Singh, PIO-cum-EE(PWD), Yingkiong Division, Upper Siang District , Arunachal Pradesh, and the Appellant Shri Shoney Pertin attended the hearing through online audio conferencing. The Appellant vide letter no. NIL Dated 18/11/2020 and verbally informed the Commission that the PIO has furnished all the information as directed by the Commission in the last hearing and the Appellant is satisfied with the information furnished by the PIO.
