ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Ms Yajum Nomuk, Nomuk village, Kamba West Saing District, Arunachal Pradesh, for non-furnishing of information, by Shri Kirba Sora, The PIO-cum-EE(PHE & WS), Aalo Division, West Siang District, Arunachal Pradesh, as sought, by the Appellants under section 6(1) of RTI Act, 2005 on 21/02/2020.

Whereas, the 1st hearing was held through online video / audio conference on 8th December'2020. Shri Kirba Sora, The PIO-cum-EE(PHE & WS), Aalo Division, West Siang District, Arunachal Pradesh, and the Appellant's son, Shri Jumdo Nomuk appeared in the hearing through online video conferencing. The Appellant Ms Yajum Nomuk was found absent during the hearing. The Appellant's son informed the Commission that the PIO has not furnish any information. The PIO informed the Commission that due to March ending, lock down due to COVID-19 and his health problem he could not furnish information to the Appellant within stipulated time. The PIO also informed that he is undergoing cancer treatment and has joined the duty on 2nd December'2020. Moreover, the PIO informed that with the help of his Dealing Assistant he has collected the information and shall handover the information to the Appellant.

Whereas, the Commission in view of health issue of the PIO and lock down due to COVID-19 Pandemic, taking leniency directed the PIO to furnish the information to the Appellant within ten days from the date of issue of this order. The Commission also asked the Appellant to receive the information go through and convey his satisfaction or dissatisfaction before the next date of hearing.

Whereas, the 2nd hearing was held on 12th January'2021. Shri Kirba Sora, The PIO-cum-EE(PHE & WS), Aalo Division, West Siang District, Arunachal Pradesh, and the Appellant Ms Yajum Nomuk were found absent during the hearing. However, Appellant submitted a letter NO. NIL Dated the 6th January'2021 informing the Commission that the PIO has furnished all the information as sought by her in the Form A and is satisfied with the information furnished by the PIO.

Whereas, the Commission taking leniency in view of health issue of the PIO and satisfaction of the Appellant decided to dispose of the case.

Therefore, the case is hereby disposed of.
