JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Papu Dadda on 17.06.2020 filed an RTI application under Form-A before the PIO-cum-DCF, Shergaon Forest Division, Rupa, West Kameng District, whereby, seeking various information, regarding state campa from 2015-16 & 2018-19. Appellant having not received any response from the PIO, filed the First Appeal before the First Appellate Authority, CCF Banderdewa, on 15.09.2020. Having receipt of the first appeal, the FAA heard the same on 30.10.2020 and directed the PIO to furnish the required documents available with him as sought to the applicant within 15th days from the date of issue of the order. Appellant, having not received the required information from the PIO as directed by the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 161-2020 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for the first time on 11.02.2021 and the same has again come up today on this 12th day of August' 2021 for disposal of the appeal. Appellant and PIO are both present through audio conferencing. Appellant expressed his satisfaction as to receipt of all information so sought from the PIO and prayer the Commission for disposal of his appeal.

In the result this appeal stands disposed off and closed. Judgment/Order pronounced in the open Court of this Commission today on this 12th day of August' 2021. Each copy of Judgment/Order be furnished to the parties.
