JUDGMENT/ORDER

This is a complaint filed under sub-section (1) of Section 18 of the RTI Act, 2005. Brief fact of the case is that the complainant Shri Vijay Pertin on 30.06.2020 filed an RTI application under Form-A before the PIO-cum-EE, WRD, Roing Division, Lower Dibang Valley District, Arunachal Pradesh, whereby, seeking various information, as quoted: ***Details of repair and maintenance of M.I.P at Kengkut in Lower Dibang Valley District, Arunachal Pradesh.*** The complainant after receiving of all information so sought by him lodged a complaint before the Commission on 03.12.2020 under Section 18 of the RTI Act, 2005 to the effect that the PIO has charged him the cost of information in excess than required cost of information. The Commission being receipt of the complaint, registered it, being APIC-No. 167/2020 and processed the same for hearing and disposal.

Accordingly, matter came up for hearing before the Commission for four consecutive hearings on 21.01.2021, 04.03.2021, 22.04.2021 and 19.08.2021. In this final hearing of the complaint on 19.08.2021 the complainant is present and the PIO is, though not present, represented by his APIO, Er. Tumpi Ete before the Commission through audio conferencing. After hearing both parties. I do not find any merit in the complaint. And, accordingly, the complaint stands rejected.

In the result this complaint stands rejected and disposed off for once for all. Judgment/Order pronounced in the open Court of this Commission today on this 19th day of August' 2021. Each copy of Judgment/Order be furnished to the parties.
